

DAY 1: REALITIES OF MIGRATION

THE REALITIES OF MIGRATION IN ASIA

The inaugural session began with a keynote address by **Christine Nathan**, President of ICMC, followed by **Mungreiphy Shimray**, Regional Coordinator in Caritas Asia, who presented on the current situation of migrants across the continent.

BIBLICAL MIGRATION JOURNEYS

Sr. Dr. Rekha Chennattu, Professor of Biblical Studies and Superior General-Religious of the Assumption, guided us through God's biblical and theological vision of migration.


PAPAL MESSAGES ON MIGRATION

Bishop Allwyn D'Silva of FABC-OHD/CCD shared his reflections on the teachings of Pope Francis and Pope Leo XIV on migrants.

The messages spanned decades, reminding us of the Church's long-standing tradition of welcoming strangers, emphasizing that our response to migrants and refugees is an essential part of our Christian faith.

These reflections served as a reminder that the Church's stance is rooted not just in compassion, but in a rich history of papal teaching that calls for solidarity with our brothers and sisters on the move.

with the mission of building up a society where all can enjoy the fullness of life, where no one is forced to leave his/her homeland, and where strangers – migrants and refugees – are welcomed with love and respect.





The first facilitation session produced the following reflections:

BE A GUIDING LIGHT

To be a guiding light, we are called to equip ourselves with knowledge and skills to be a trusted source of information - improving flow of information to migrants, act to dispel myths and stereotypes, and learn relevant labor laws.

REACH OUT AND WALK TOGETHER

While the universal church takes lead in the mission, we become the bridge between migrants and existing stakeholders from other faith communities, government agencies and other NGOs to strengthen our collective work.

EMPOWERMENT IS OUR MISSION

Embracing a 'conversion of the heart' to shift from temporary assistance to empowering migrants to be their own advocates allowing us to express full solidarity with the poor and suffering.

INVEST IN A JUST WORLD

View migration challenges with a spiritual lens. Support efforts that address the root causes of forced migration, advocate for fairer economic policies to create a just world where dignity is non-negotiable and everyone can thrive.



LEGAL LAWS AND CHALLENGES FOR MIGRANTS

MALAYSIA

Malaysia signed a number of UN Human Rights Charters yet does not display migrantfriendly treatment in reality.

- Recent law reforms have raised minimum wages for all workers, though it does not cover foreign domestic workers.
- Though judicial courts clearly extends protection to all migrants including undocumented, the enforcement is not the same.
- Mistreatment comes in various forms - labour exploitation, passport witholding, poor recourse to justice, workplace hazard.

PHILIPPINES

The Department of Migrant Workers (DMW) is responsible for the protection of rights and welfare of Overseas Filipino Workers (OFW).

- At the same time, multiple departments oversee affairs for migrants and refugees.
- Filipino overseas
 migration is deeply
 historical, also
 accelerated by labour
 export programmes.
 Diversity and disasters
 also shape internal
 migration.
- Migration drives remittance, support for housing, education but is also linked to social issues of family breakdown, abuse etc.

INDIA

- 93% of India's population work in unorganised sectors, with little legal protection leading to exploitation.
- Migrants and refugees are amongst the most vulnerable in this workforce, and with little or no trade representation, though collective resistance exists.
- India's labour law reforms weakened protection for workers, especially migrants and refugees, often leaving them at the mercy of the employer.



DAY 2: WITNESSING GOD'S SERVANTS IN MIGRANT WORK

The first half of the day consisted of separate visits to three local and refugee-led organisations - Myanmar Ethnics Organization (MEO), Tenaganita and North South Initiative (NSI) which provided first-hand exposure and witness to the scope of community mobilisation, advocacy, and direct support extended to vulnerable communities.

Each group were received by the leaders of each organization - Paupi Kai Sian Pau of MEO, Glorene Dass of Tenaganita, and Adrian Pereira of NSI.

During the second half of the day, we heard from representatives of the local Church and Catholic-based organisations sharing their inspirational experiences of serving migrants and refugees in pastoral, medical, gender, and humanitarian dimensions, each contributing their unique strengths to the protection and service of migrants and refugees.

The panel consisted of **Brittocia Arulanthu** from Global Shepherds Berhad (GSB), **Sarah Ann Chou** from A Call to Serve (ACTS), **Josephine Tey** from the Archdiocese of Human Development (AOHD) and **Pohleen Tan** from ICMC. We further witnessed the testimonies of **Doris Ciego** and **Desiderius Dhare**, which moved us with their personal struggles and courage.

CONVERSATION IN THE SPIRIT

Guided by the Synodal reflections on migration and the challenge of building intercultural communities, the following themes emerged from the group discussions:

HOPE AMIDST CHALLENGES

Migrants embody resilience in the face of risk, obstacles and limited resouces. Their persistence is a source of hope for the Church's mission.

COMPASSION AS THE HEART OF MISSION

Compassion extends beyond a 'listening heart' and calls for accompanying, engaging, and accepting migrants.

COURAGE AND PERSISTENCE OF MIGRANTS AND ADVOCATES

Recognise the inspirational qualities of migrants and the persistence of advocates in confronting oppressive systems.

VALUE OF MIGRANTS' CONTRIBUTIONS

Shift away from the narrative of vulnerability by appreciating the gifts that migrants contribute from faith, talent, skills, time and cultural richness

SYNODALITY AND NETWORKING

Journeying together in solidarity, and expanding networks within the Church and across organisations.

COLLABORATION AND COLLECTIVE ACTION

Building stronger partnerships across NGOs, ecclesial institutions, and grassroots communities is essential.

FORMATION AND CONSCIENTIZATION

Migrant realities should be integrated into Catholic formation, including seminarian and religious training, thus embedding migrant pastoral care in our mission.

ADVOCACY AND SYSTEMIC CHANGE

Harness the Church's institutional influence for advocacy, , particularly in addressing root causes and systemic injustices.

Where there is crisis, there is growth. Where there is a need, there is a solution.

DAY 3: CONVERGING KNOWLEDGE FOR FUTURE

The last day of the workshop began with sharings from various Catholic organisations on best practices to inform and inspire future work.

Hosted regional seminars and conducted exposure visit to Rohingya refugee camps, and exchanges on renewable energy and migration as intersecting issues. Led webinars and proposed for a Solidarity Network for strengthening regional practices

ICMC

DAVIDE BERNOCCHI

Named as one of the Associated Institution alongside Caritas Internationalis by the Dicastery for Promoting Integral Human Development. Coordinates Catholic engagement in global migration forums and support episcopal conferences.

JPIC

FR. ROY THOMAS

Supported various migrant ministry and antitrafficking activities across Asia. Produced collaborative publications, hosted webinars on migration and trafficking, collaborate with other Catholic organisations

CARITAS

ART NUGROHO

Utilises the Human Mobility Network and collaborates with the Greater Mekong Sub-Region Anti-Trafficking Task Force in addressing various migration and trafficking challenges, raising awareness and advocate at national and regional levels.

TALITHA KUM

SR. PAULA KWANDAO

Operates through a network model emphasising bottom-up, intercongregational structure rooted in local context but globally connected. Focuses on strength-based presence, survivor-centred approaches and youth leadership

FORGING A WAY FORWARD

In a final facilitation of Conversation in the Spirit, participants were invited to engage in a forward-looking discernment reflecting on the experiences and sharings from the past three days answering four pertinent questions.

VULNERABILITY AND EXPLOITATION

Fear of authorities, wage theft, labour exploitation, and human trafficking

LACK OF PRE-DEPARTURE PREPARATION

Migrants leave their country without adequate vocational or language skills

LEGAL PROTECTION AND JUSTICE

Weak legal frameworks, corruption and exploitation, lack of recognition, documentation and access to justice lack of recognition, documentation,

DISCRIMINATION AND SOCIAL EXCLUSION

Stigma, lack of social cohesion and limited integration

OUTLINING CONCRETE STEPS

PASTORAL CARE AND SAFE SPACES

Diocesan migrant desks for pastoral support and referrals. Shelters, spaces for cultural celebrations, learning centres for migrants

CAPACITY BUILDING AND SKILLS DEVELOPMENT

Cultural orientation trainings, vocational skills for migrants, and sensitisation trainings for pastoral workers

LEGAL AND PARALEGAL SUPPORT

Diocesan migrant desks for pastoral support and referrals. Shelters, spaces for cultural celebrations, learning centres for migrants

INFORMATION AND AWARENESS

Education on safe recruitment, scams. Create platforms for information exchange

COLLABORATING AT ALL LEVELS

Partnerships with international Catholic bodies, NGOs, and interfaith groups to strengthen advocacy

Regional strategic planning and resource pooling across Asia-Pacific, FABC coordinate regional efforts

REGIONAL

Local level collaboration with government and other bodies on migrant protection

NATIONAL

DVOCACY at

national and international levels to influence migration policies

OUR COLLECTIVE

COMMITMENT

to train pastoral ministers, lay leaders and migrants

IARING of time, expertise, and finances for collaborative initiatives

SOLIDARITY through standing with migrations side by side and upholding their resilience

IETWORKS that strengthen case management, with occasional congregations

A CALL TO ACTION

By the end of the workshop, we recognised that our response to migration must be both pastoral and prophetic. We are called to accompany migrants with compassion, advocate for their rights with courage, and collaborate with hope across boundaries.
